Note: SCHEME I (NON REFUNDABLE)

Note: SCHEME II (REFUNDABLE)

In the event the DP Account is closed within less than 365 Days, the net refund would be after adjusting AMC Rs.250 plus applicable Service Tax.

TERMS AND CONDITIONS

1. Both the Schemes are applicable to Individual BO Accountholders only.
2. All outstanding due will be adjusted at the time of refund and only net amount, if any, shall be paid within 15 days from the date of receipt of written request for closure of BO Account.
3. Scheme II is available with compulsory Auto Pay-in facility with VSSL.
4. Other than AMC, BO/Client has to pay all charges as applicable.
5. Scheme once opted, no switch over to other scheme is allowed.
6. The Management reserves the right to amend any of the terms and conditions from time to time as may be required by VSEL, CDSL, SEBI or any Statutory Authorities at any point of time without giving Notice or without assigning any reason whatsoever.
7. Management reserves the right to withdraw the Scheme at any point of time without giving notice or without assigning any reason whatsoever.
8. In case of Closing of Account by BO for whatsoever reason, no amount will be refunded in case of Scheme I.
9. Deposit will be refunded (as per Scheme II) subject to submission of original deposit receipt.
